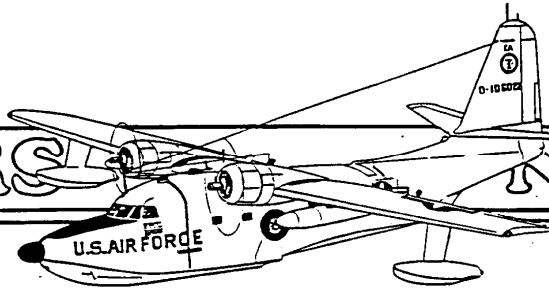

## Old Timers Luncheon

*Wednesday, March 15, 2001*

The 2001 Annual Meeting of the 129<sup>th</sup> Alumni and Heritage Association will be held in conjunction with the Annual Old Timers Luncheon on March 15, 2001, at the Alameda Elks Lodge, 2255 Santa Clara Avenue, Alameda.

There will be no guest speaker at the Old Timers Luncheon. A video of the 2000 Chino Air Show will be shown throughout the gathering, allowing more time for socializing. There will also be the now-traditional raffle for aircraft artwork prepared by Jay Craddock. This year the featured prints are the SA-16 sitting on Clear Lake and the current assigned 129<sup>th</sup> aircraft, MC-130P and HH-60, over the Golden Gate Bridge. All proceeds go to the scholarship fund.

## Board Election

*March 2001*

An election for the three at-large Directors is scheduled for 2001. The AHA Corporation Bylaws proscribes that Directors are elected in odd number years (2001) and Officers are elected in even number years (2002).

Ballots, a self-addressed stamped postcard, were mailed to all members in early February. There is no write-in provision. Ballots must be returned with a postmark no later than March 2, 2001 to be valid. The three nominees with the highest number of votes will be declared Directors, and will be announced and begin their two-year term at the Old Timers Luncheon

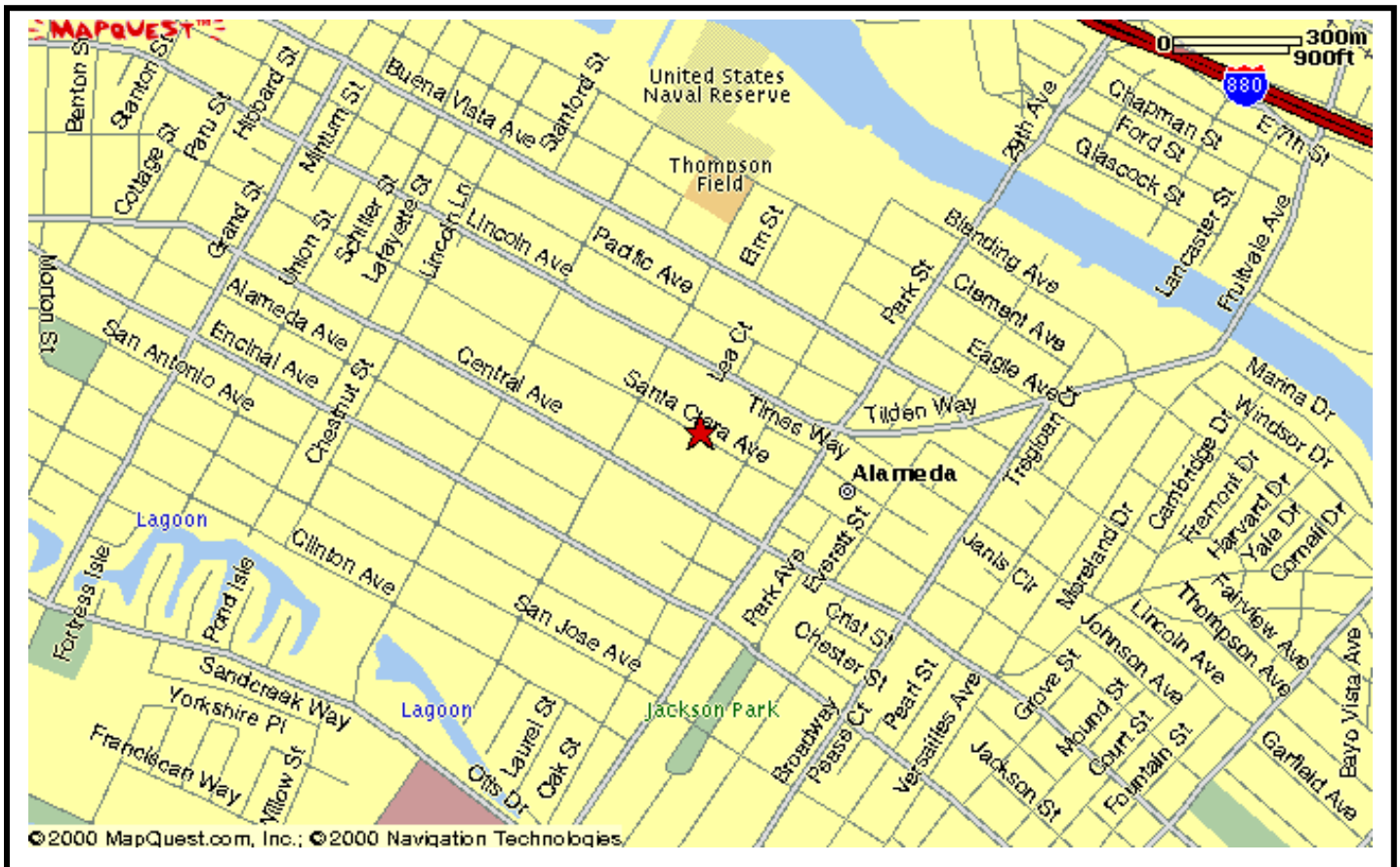

## Space A Travel Handbook Just Off the Press

Members of the Air Force retiree community who do a lot of traveling might want to consider the recently published Worldwide Space-A Travel Handbook. At \$25 plus \$3 S&H and another \$2.06 in tax for Texas residents, it's not cheap but it seems to contain the information most needed by the Space-A traveler, including billeting, flights, RV and camping. Charts, abbreviations, maps, and type sizes have been refined. In addition, it now includes a bimonthly Space-A Travel Update to distribute information quickly.

Retirees should check the Army and Air Force Exchange Service (AAFES) outlet first for a discounted price. If the AAFES facility doesn't carry it, a toll-free number - 1 888-277-2232 - is available for orders only from 8 a.m. to 5 p.m., Monday through Friday. Most major credit cards are accepted.
