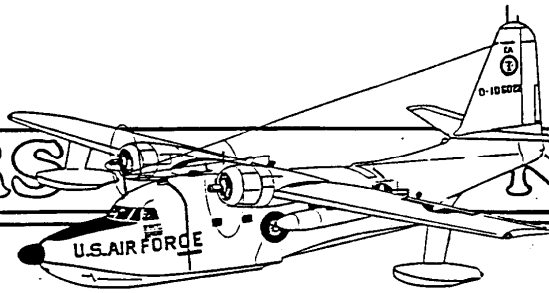

Disney Salutes Armed Forces

129th Public Affairs Rescue Gram

February 2002

From January to the end of April, "Disney's Armed Forces Salute" will offer discounts at both the Walt Disney World Resort in Florida and the Disneyland Resort in California. Active US military personnel, with proper US military identification, are eligible, including active members of the United States Coast Guard and activated members of the National Guard and Reserves.

At Walt Disney World Resort, each active member of the US military may obtain one complimentary seven-day ticket during the offer period (January 1, 2002, to April 30, 2002). US military personnel are also eligible for discounts at select Disney resorts, starting with a \$49 per night rate (plus tax) at Disney's All-Star Resorts.

At the Disneyland Resort, each active service member may purchase 50 percent discount tickets to the Disneyland Resort theme parks for up to five friends and family members. Additionally, the service member accompanying the party will receive the same ticket for free. According to the Disneyland website, this discount is only available at the ticket windows, and activated members (or their spouses) of the Guard and Reserve must show active duty orders.

The 129th AHA has had a very good year. We ended the year with more money in the bank than we had at the beginning of the year. We have sufficient funds in the scholarship account to award five scholarships for the year 2002. Thank you all for your generous donations and hard work at the fundraisers. Senior Retired Leadership Conference

March 28 - 29, 2002

The Office of the Adjutant General is once again hosting the annual Senior Retired Leadership Conference. Designed for retired personnel with rank of E-8 or E-9, or O-6 and above, the conference is a review of the California Guard's many and varied accomplishments during the past year, as well as its plans for the future.

This year's gathering promises to be the most unique, informative, and exciting conference ever, with a wide variety of highly informative briefings, including in-depth details regarding the California Guard's past, present, and future Homeland Security missions. It is a rare opportunity for us to keep our valued retiree force of senior officers and NCOs informed and up-to-date on California National Guard activities.

To begin this year's event, we plan to hold a two-hour social "icebreaker," Thursday evening, March 28, with the actual update briefings occurring from 9:00 a.m. to 3:30 p.m. on Friday, March 29. Both events will be held at Sacramento's new Marriott Hotel near State Headquarters. Every attempt has been made to make this year's conference the finest we've ever had: a four-star location; new, state-of-the-art audio-visual equipment; excellent food and accommodations; and a chance to meet with old friends. It's a conference you definitely don't want to miss.

For the registration fee of \$30.00, you get the Social (No-Host Bar) on Thursday, March 28, and lunch and refreshments on Friday, March 29. Military Air transport will be available from Los Alamitos, and possibly from Fresno. If sufficient pre-registrations are received by March 11 requesting MILAIR from Fresno, we will coordinate for either the Los Alamitos aircraft to stop in Fresno or arrange for an additional aircraft.

US Uniformed Service ID Card

Is your ID Card Current?

Your Air Force identification card is a very important document that should be current and in your possession at all times. What about your spouse? Does she or he have an Air Force identification and privilege card? If she has one, is it current? Or has the date on the card expired? While our US Air Force retired (gray) ID card has no expiration date, dependent cards must be renewed periodically.

Take a few minutes and review both of your ID cards. Current retiree ID cards (DD Form 2 Retired) will be gray, and your spouse's card (DD Form 1173) will be tan.

The expiration date will be in the top, right-hand corner of your spouse's card. If the date is past, the card is invalid and must be renewed if your spouse wishes to be authorized to use military exchanges, commissaries, and MWR facilities. Current ID is also required for flights on military aircraft (Space A), use of military accommodations, and hospitalization.

I recently had coffee with one of our AHA members, CMS Roy Frances. Roy informed me that Mr. R. McBride III at the US Army HQ 91st Division, Bldg 500, Parks RFTA, Dublin, CA, has the capability of handling any of your ID card questions and renewals, as well as providing information regarding the DEERS and TRICARE medical programs.

I visited with Mr. McBride at Parks RFTA and found him to be very knowledgeable and helpful. Mr. McBride is a civilian working varied hours at Parks, so it would be appropriate to call and make an appointment.
