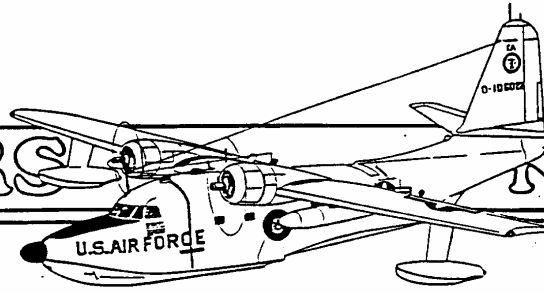

## By the Dawn's Early Light *A Life is Saved*

You've never read about it, and you haven't seen it on TV. The Navy still isn't discussing it, but it was one of the most daring at-sea joint rescue missions attempted in recent times, and the California Air National Guard was a major participant.

The 129<sup>th</sup> Rescue Wing, whose motto "These things we do that others may live," combined with "A Few Good Men" blended into a dramatic mission August 23, 2003, when the CaANG unit and the U.S. Marine Corps teamed for a dangerous rescue mission 600 miles at sea in the Pacific Ocean.

A 23-year-old Navy sailor aboard a submarine was facing life threatening consequences as a result of a severe kidney ailment that without immediate medical attention could have resulted in kidney failure. Normally, the 129<sup>th</sup> has the assets to conduct long-range over water search and rescue missions, but current operations tempo had strained normal resources.

## Board Elections - Officers

*March 2004*

The Unit had an HH-60G Pavehawk available at Moffett Federal Airfield, the home of the 129<sup>th</sup>, but the unit's only available MC-130 Combat Shadow tanker was on its way to Florida on another mission.

A call went out to the Marine Corps, which had previously trained with Air Force rescue aircraft and whose KC-130 Hercules can air-to-air refuel the Pavehawks. The Corps, eager to help, sent a KC-130 from the "Raiders" of Marine Aerial Refueler Transport Squadron 352 from Marine Corps Air Station Miramar, near San Diego.

The 129<sup>th</sup>'s MC-130 was recalled from its Florida mission while planners analyzed the challenges and envisioned various scenarios to successfully complete the mission. After deciding on the best course of action, the staff organized medical teams from the Coast Guard, Navy, and Air Guard, and plotted the best place to rendezvous with the submarine, in the middle of the ocean, at night, and with the knowledge that no one in the 129<sup>th</sup> had ever removed a patient from a submarine before.

The tankers, helicopters, and crews assembled at Moffett Field and lifted off at 2:00 a.m. The crew included pilots CPT John Brunner and 1LT Hung Nguyen; Flight Engineers TSgt Chris Lassiter and SRA Shane Cook; Pararecuemen (PJs) CMSgt Scott Simpson and SRA Clay Bendle.

Aboard the submarine, the sailor's medical condition stabilized somewhat but still remained critical. Because of the nuclear submarine's classified operations, the flight crews had only the submarine's grid square on a map rather than its exact location. The helicopter and KC-130 flew more than 600 miles over the Pacific and waited for the submarine to surface. Two hours after take off, the helicopter needed refueling from the KC-130. This is a dangerous procedure under optimal conditions and in the dark it's quite a challenge.

After refueling the HH-60 twice, the KC-130 increased speed and went on ahead to locate the submarine. In the helicopter, the crew reviewed procedures and the challenges associated with bringing a patient and PJs aboard the helicopter at night. The KC-130 contacted the submarine and circled at 11,000 feet until submarine personnel confirmed they were ready. The KC-130

## Wild Weasel Reunion

About 75 wild weasels attended a reunion in Washington DC 4-7 September 2003. A short tour of the Pentagon with former Wild Weasels having experience in F-105Gs, F-4Cs, and F-4Gs attended. The current Chairman, Joint Chiefs of Staff General Richard B. Myers, has been assigned since October, 2001 (<http://www.dtic.mil/jcs/core/chairman.html>).

Attendees cruised the Potomac to Mt. Vernon accompanied by Gen. Myers for the first half of the cruise. Later we met him at his home for about an hour of "old times" and relaxation. We then met for dinner at the hotel. All guests were honored with a brief talk by General Myers, who stressed that President Bush is focused on ending terrorism against America and Americans, and restoring Iraq.

Gen. Myers has been confirmed as Chairman, Joint Chiefs, for two more years, which will mark over 40 years of continuous active duty for the Kansas State University AFROTC graduate. Gen Myers and I were assigned to the 67th TFS in Kadena in 1972 - 1973. The squadron deployed to Korat RTAFB, Thailand from Sep '72 - Feb '73 in support of Linebacker 2 at the end of the Vietnam War. His recent previous assignments included Commander PACAF (Jul '97 - Aug '98); Commander North American Aerospace Defense Command (NORAD), US Space Command' AF Space Command (Aug '98 - Feb '00); Vice Chairman Joint Chiefs of Staff (Mar '00 - Sep '01); and Chairman Joint Chiefs (Oct '01 - Present).

The next planned Wild Weasel Reunion is planned in three years for either Hawaii or Las Vegas. The General plans to attend.

also served as a radio patch between the submarine, the HH-60, and the additional tanker launched from Moffett to refuel the helicopter on its way home.

Just after dawn, the helicopter approached the surfaced submarine and the pilots hovered the HH-60 above the sub and behind its conning tower. "The Navy was totally squared away when we got there; they had the patient ready in the rescue harness and ready to go," said Nguyen. "We lowered the PJs and made one orbit around the sub, came in, and picked them up." Total time from drop-off to pick-up: seven minutes.

On the flight home, the C-130 tanker from Moffett had arrived on station and the Marine Corps aircraft returned to Miramar. The 129<sup>th</sup> C-130 refueled the helicopter twice on the way back to the coast. When the aircraft were over land, the tanker headed for Moffett Federal Airfield and the HH-60 went to a waiting ambulance at a soccer field at Stanford University.

This was the 304<sup>th</sup> life saved by the 129<sup>th</sup> Rescue Wing with every member of this joint team exemplifying the mission of "These things we do that other may live."

## Delinquent Dues

*Past Due Memberships*

The Board of Directors has received complaints regarding the listing of dues delinquent members in the OI' Timers Noozze. All six (6) elected members of the Board reviewed the policy of listing the names of dues delinquent members in the newsletter, and voted unanimously to continue the policy.

Be aware that after the original dues notice is sent out at the beginning of the year, 2 additional notices are sent by mail, several reminders are sent by email, and telephone contact is at least attempted. Additionally, generic reminders are published in the newsletter - which has "DELINQUENT" on the labels. Names are not published until after at least 2 formal dues reminders (after the initial billing) have been mailed. All mailings are sent "Address Correction Requested" and re-sent if address changes are received.

These people have indicated they wish to be a member of the organization. With membership goes the responsibility of paying one's dues. If one chooses not to continue that membership, all the Board is requesting of these members is a response such as "no thank you", "take my name off the list", "no longer interested", etc. Without that response, we are required by the corporation by-laws to go through a formal expulsion procedure for non-payment of dues after 2 years. The names of those members are required (those pesky by-laws again) to be part of the official records of the Association - in other words - listed as terminated for lack of dues payment in the Board Meeting Minutes which are published on the web site.

If you would care to discontinue your membership in the 129th Alumni and Heritage Association and no longer receive communications such as the OI' Timers Noozze, please advise us accordingly. Otherwise, you will receive your dues notice for 2004 shortly after the first of the year.

Please remember, your dues must be current – that is paid through 2003 – to be eligible to receive a ballot in the upcoming elections. Please check your label on this issue of the OTN. If it has "DELINQUENT" printed thereon, please forward either your 2003 dues or your resignation immediately.
