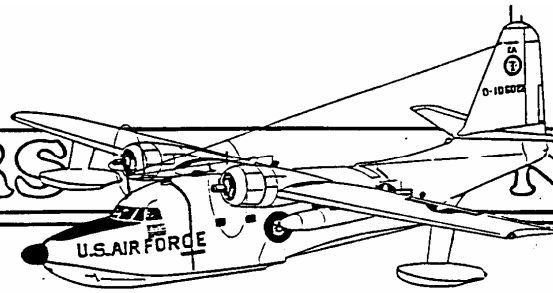

An election for the three Officers is scheduled for 2004. The AHA Corporation Bylaws proscribe that Officers are elected in even number years (2004) and Directors are elected in odd number years (2005).

The AHA President, Jay Craddock, appointed an Election Committee chaired by SMS Don Delucchi, Director. The committee is responsible for gathering nominations, reviewing qualifications, recommending candidates, distributing, collecting, and counting the ballots. The newly elected Officers will be announced at the Association's annual meeting, the Annual Old Timers' Lunch, scheduled for March 24, 2004.

All AHA members in good standing may vote for Officers. Ballots have been included in your newsletter if you paid your 2003 membership dues. If your last year's dues were not paid, you are not considered to be in good standing and are not eligible to vote.

There are four names on the ballot: LTC Jesse (Jay) Craddock – President; CCMS Ken Moore – Vice President; COL John Ruppel – Secretary-Treasurer; and COL Ray Fitts - President. After reviewing the qualifications of the nominees, the election committee recommends: President – Jay Craddock; Vice President – Ken Moore; and Secretary-Treasurer – John Ruppel. Those elected will be announced and begin their two-year term at the Old Timers' Luncheon

Membership News and Notes

Reminders and Updates

Dues billings for 2004 have been mailed, and dues should be paid by March 24, 2004. You may send your dues check with your Old Timers' Luncheon reservations, or you may pay at the luncheon. After that date, dues are considered delinquent.

Beginning with the June 2003 edition of the newsletter, the Board directed that a reminder will be published listing the names of those who have not yet paid their dues.

Effective December 31, 2003, any member who has not paid their 2003 dues will be suspended from the mailing list (both snail-mail and e-mail) of the Old Timers' Noozze until all arrears are paid. This policy was finalized at the July 2003 Board meeting.

If you for some reason choose to discontinue your affiliation with the 129th AHA, please do not just quit paying your dues. The by-laws require that you give notice at the end of the year that you wish to resign from the Association. Attach a note to your billing notice requesting your name be removed from the membership. You cannot resign unless you are a member in good standing (translation: current with your dues). If you are sufficiently delinquent in dues payment, the Board can vote to expel you from the Association. If in the future you wish to re-establish your affiliation with the 129th AHA, you must petition the Board for membership and pay current dues. The Board may elect to assess dues in arrears.

Don't want to hassle with remembering to pay your dues? The Board has decided you may prepay up to 5 years of dues at the current rate (that would be \$50 currently). That will be drawn upon until exhausted, and in the final year you will be responsible for any shortfall. In other words, you will not be protected from any dues increases.

Remember – your dues and donations are the primary support of the 129th AHA. Your membership is both needed and valued.

ABOUT THE BOOK:

Demons Phantoms and Me: "A Love Affair with Flying" is a wonderful story of a NASA Test Pilot's aviation adventures from learning to fly as a teenager in Aeronca Champions, to piloting Phantom IIs off an Aircraft Carrier. The author takes you into the cockpit and eloquently shares the emotions, feelings and trepidations that accompany the process of becoming a Navy Fighter Pilot and logging over 300 Carrier landings. You will experience the exhilaration of that first carrier landing and the apprehension and anxiety a Naval Aviator undergoes as he threads the tiny margins of safety to land a high performance fighter on an often rolling, pitching Carrier deck on a black night at sea. Feel the rush of dueling with a UFO over the Gulf of Mexico and survive a deadly flight deck crash. The author freely admits this book could not have been written as it was happening. His macho image would not allow an honest outpouring of what was really going on in his mind and heart during that exciting period in his impressive flying career. It is a great trip down memory lane for anyone who went through the process or who may wonder what it was really like. The book contains over 240 photographs, most from the author's personal collection.

ABOUT THE AUTHOR:

Warren Hall has truly had a lifetime love affair with flying. He learned to fly in High School as a "line boy" at a local airport in Richmond, Virginia. After college, he became a Navy Fighter Pilot flying the F3B "Demon" and F4B "Phantom II," logging over 300 Carrier Landings. He is currently a NASA Test Pilot and has flown over 65 different types of aircraft including the X-14B, XV-15, X-22A, AD-1 Swing Wing, and the unique Rotor Systems Research Aircraft. Mr. Hall is a "Fellow" in the Society of Experimental Test Pilots. In November 2003, the San Francisco Chapter of the American Institute of Aeronautics and Astronautics designated him a "Living Legend of Aerospace." He completed twenty-eight years of continuous military flying retiring as the Commander of a California Air National Guard Rescue Group, with the rank of Colonel. Mr. Hall is currently the Assistant Director for Aviation at NASA Ames Research Center and still actively flying. He has authored 73 Technical Reports and received three International awards for technical excellence.
