

## TriWest offers New Service

*Week of November 23, 2009*

TriWest Healthcare Alliance is offering a new lung health service to West Region TRICARE beneficiaries eligible for its Disease Management programs. Beneficiaries suffering from chronic obstructive pulmonary disease, or COPD, can receive extra help for a group of lung diseases that include emphysema, chronic bronchitis and, in some cases, asthma. Eligibility is determined by TRICARE and is based on claims history. Once a beneficiary is identified as eligible to participate in the program, DoD refers the beneficiary to TriWest. ## Improved Security Changes for the myPay User

DFAS will implement new [myPay](#) access requirements to increase the security of user information. This change will require you to establish a new user name (login ID) and password. Requiring you to establish a new customized Login ID and strong Password gives you more protection and increases the security of your personal information.

When logging into [my Pay](#) the first time following implementation of the new security enhancements, you will be allowed to use your existing login ID and PIN and will be prompted to change your login credentials.

New login IDs will require six to 129 alphanumeric characters that will be unique to one user only. If you attempt to create a login ID that has already been established you will be prompted to create a different login ID. Help screens will contain the login ID requirements.

You will be required to establish a password to accompany your customized login ID. Passwords must be no less than eight and no more than 15 characters. Help screens will contain the password requirements.

If you have established a Restricted Access PIN, you will also be prompted to establish a limited access login ID and password using the same requirements.

Use of the myPay interactive voice response system, which allows telephone access to certain pay information, may still be entered using the Social Security number and myPay PIN.

## 2009 Tax Form, Pay Statement Availability Schedule

CLEVELAND (AFRNS) – Air Force retirees with a myPay online account can now download their annual account statements. Internal Revenue Service 1099R forms for retirees and annuitants will be posted December 14, 2009.

Retirees who rely on the U.S. Postal Service for DFAS correspondence can expect to see their account statements soon as they are now in the mail, while tax forms will be mailed December 11, 2009. For annuitants, account statements and 1099R forms begin mailing December 14, 2009.

Statements and forms are mailed to the address on file with DFAS.

# *Lt Col Thomas J. Laut*


*2 December 1944– 11 November 2009*

Lt Col Thomas J. Laut passed away peacefully in his San Ramon home, surrounded by family and friends, after a short battle with cancer. Tom was adored and will be missed by his daughter Jennifer Rice and son Aaron Laut. He is also survived by brother, Larry Laut; former wife, Nina Irvin; son-in-law, Chris Rice; and a multitude of friends, family, and associates.

Son of Kenneth and Dorothy Laut (both deceased), Tom was born in Massachusetts where he spent much of his childhood and adult life. He grew up primarily in Ohio and graduated from West Lafayette High School in 1962. In his youth, he spent summers at his beloved family cabin in the Berkshires, became an Eagle Scout, and worked as a camp counselor at Camp Chingachgook located near Lake George in New York.



Tom graduated from Ohio State University in 1968, shortly before entering the U.S. Air Force as a commissioned officer which began a dedicated military career. He quickly distinguished himself as both a fixed wing and later a combat helicopter pilot. His professional and heroic combat rescue service brought him many military honors and awards recognition including the Silver Star and the Distinguished Flying Cross. His 32-year military career, which spanned both the U.S. Air Force and California Air National Guard assignments, took him all over the world and touched many lives. He was a 20-year veteran of the 129th Rescue Wing located at Moffett Field, California, where he also served as an Instructor Pilot. His humanitarian rescue and life saving "anytime, anywhere" efforts over both land and sea continued until his retirement in 2000. His service brought great credit upon himself, the State of California, and the United States of America. He was the epitome of a Citizen Soldier. Shortly after retiring he also enjoyed a brief employment with Southwest Airlines.



Tom had a love of road trips and travel, the outdoors, antiques, the following of current events and financial markets, and animals. Since retiring, he most enjoyed spending time visiting family and friends. An avid reader and lifelong learner, Tom could be counted on to have knowledge of and discuss happily most any topic. His keen insight, unique sense of humor, strength of character, and indisputable integrity enriched many people. His warm heart made those fortunate enough to know him honored to share in his all too brief life.



*10 November 1951 – 31 October 2009*







Bobby Joe Wagner, 59, of Westlake Village, California, passed away on October 31, 2009 in Thousand Oaks, California of multiple organ failure. He was born on December 8, 1949, in Lindsay, Oklahoma, the son of Dale and Mary Wagner. He leaves behind his wife, Toni; his daughters, Heather and Elissa, of Thousand Oaks; his son, Robert, and daughter, Rebecca, both of Phoenix; his brothers, Stephen, of Bakersfield; and Michael, of Tennessee; his sister, Eloise, of Tennessee; and his beloved Cockapoo, Tara.

Bob spent his high school years in the San Francisco Bay area, graduating from Newark High School, and attended Ohlone College before enlisting in the Air Force in 1968. He had a distinguished 22 year military career serving in both the Air Force and Air National Guard. MSgt Bobby Joe Wagner served 7 years active duty Air Force as an Aircraft Mechanic on B-52, KC-135, and RC-121 aircraft. He joined the 129th ARRG at Hayward in 1978 as an Aircraft Mechanic. During BJ's 17 year career with the 129th, he served in many career fields and steadily progressed to ever higher levels of responsibility and leadership, cross-training from aircraft maintenance to Military Personnel as an Education & Training NCO, and rising to Force Management Superintendent. During his Military Personnel career, BJ served as the chief recruiter for the 129th and achieved an outstanding record of recruitments. Every career field within the 129th Group benefitted greatly from his manning efforts, and he was recognized as the California Air National Guard Recruiter of the Year. BJ spent the remainder of his career as a logistician with the 129th Civil Engineering Squadron, planning and participating in many field deployments with our Prime Beef team. BJ received the Air Force Achievement Medal (with 1 device), the Air Force Commendation Medal (with 1 device) and the Air Force Meritorious Service Medal. MSgt Bobby Joe Wagner retired as an AGR with 22 years combined service on November 6, 1995.

After leaving the Air Guard with a service connected disability he joined his wife, Toni, in managing Travel Services of Sonoma, where he lived for 15 years.

He then turned to his favorite pastime – cooking for his friends and family. Creating a new dish always brought a smile to his face and ours since we all knew his secret ingredient – love. Bob also enjoyed all kinds of music and he especially loved attending and supporting Elissa's performances and Heathers' film projects. Bob was very much involved in acting in the Bay Area performing for TheaterWorks, Regional Artists Media and various film projects. He also loved hunting and fishing.

Beleaguered by multiple illnesses, Bob fought valiantly for several years to stay with us as long as he could. We love and miss him. He is forever our hero.

# Space-A Travel an Option for Retirees

11/18/2009 - SCOTT AIR FORCE BASE, Ill. (AFRNS) -- Retirees who dream of climbing an Egyptian pyramid, schussing down a black diamond ski slope in Bavaria, or walking on a Hawaiian beach can make these dreams come true with space-available travel.

Typically, these dreams require a lot of money; however, Space-A travel is free with the exception of customs or federal inspection fees on some chartered commercial air service missions.

Air Mobility Command aircraft fly all over the globe and often have open passenger seats available. An AMC aircraft takes off every 90 seconds, according to AMC officials. More than 130,000 Space-A travelers take advantage of this military benefit each year.

Retired Airmen with a retiree ID card and who are eligible to receive retired or retainer pay, fly as Category VI passengers. Since missions can be rerouted, delayed or cancelled for a variety of reasons -- weather, maintenance issues or higher priority missions - retirees need to be flexible. They need to plan for any potential delays and added expenses for stays, especially in high-cost areas.

There are four different methods for signing up for Space-A travel: in person at the passenger terminal or remotely via telephone, fax or e-mail. Sponsors must provide their name and information on all traveling dependents, and their desired destination(s).

Retirees can also use the DOD-chartered airlift missions for Space-A travel, if seats are available. Although retirees cannot visit their grandchildren in Iraq or Afghanistan, they can travel to Germany if the aircraft transitions there. If traveling overseas, retirees should know the restrictions of the host country. For example, retirees traveling to Germany are not authorized to purchase items in the base exchange, but they can go off base and shop in the local community. Status of Forces Agreements restrictions, U.S. State Department Travel Advisory guidelines, the Foreign Clearance Guide and passport and visa requirements are all necessary items to research.

### Memorial Calls for Photos of Vietnam Vets

- WASHINGTON (AFRNS) -- The National Call for Photos, a campaign to gather images of the more than 58,000 men and women whose names are on the Vietnam Veterans Memorial, was launched recently at a Newseum event here hosted by the Vietnam Veterans Memorial Fund and FedEx Office.
  - FedEx Office will use its locations across the country to help in gathering photos.
  - Established in 1979, the Vietnam Veterans Memorial Fund is dedicated to preserving the legacy of the Vietnam Veterans Memorial here, promoting healing and educating people about the impact of the Vietnam War.
  - The fund's latest initiative is The Education Center at The Wall, an underground facility near the memorial that is being designed to help visitors discover the stories of those named on The Wall and celebrate the values embodied by servicemembers from all of America's wars.
  - Exhibits will include a wall of photographs of people whose names are on The Wall, a selection of the more than 100,000 items that have been left at the Vietnam Veterans Memorial, a timeline of key military events of the Vietnam War and a history of the memorial.
  - The center also will celebrate the values embodied by America's servicemembers: loyalty, duty, respect, service, honor, integrity and courage, officials said. An exhibit will show images of those who have served in America's conflicts, from the Revolutionary War to Iraq.
  - More than \$20 million has been raised for the education center, including a \$10 million gift from Time Warner. It is estimated that the center will cost \$85 million to build.
  - Other Memorial Fund initiatives include educational programs for students and teachers, a traveling Wall replica that honors veterans and a humanitarian and mine-action program in Vietnam. (Courtesy of American Forces Press Service)
