The 1099Rs were not mailed to retirees and annuitants unless they selected the hardcopy option for their annual account statement or tax forms. Those recipients should receive their 1099Rs in the postal mail sometime in mid-January 2011. If you have not received yours by that time, verify your correct postal mailing address with DFAS by calling 1-800-321-1080.

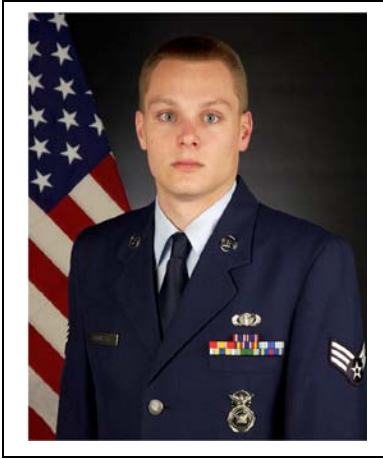

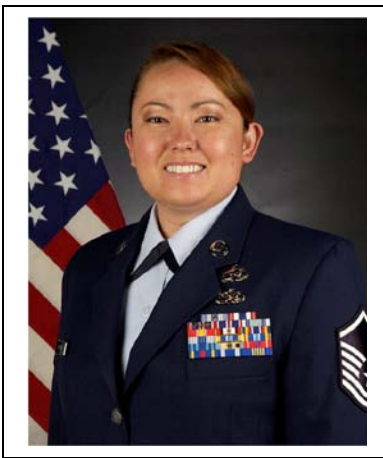

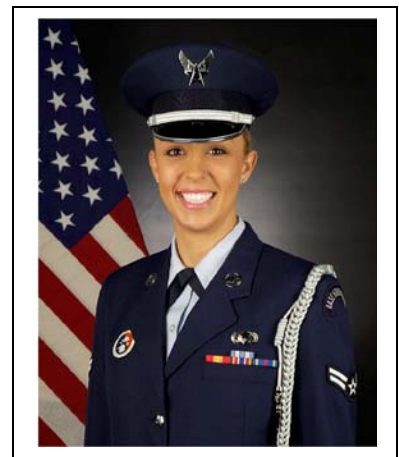

# *CMSgt Kenneth W. Huntley*

*2 August 1954 – 1 January 2011*



Kenneth William Huntley, 56, of Astoria died January 1, 2011 at home surrounded by family. He was born Aug 2, 1954 in Schenectady, NY to Harold W. and Maxine E. (Hughes) Huntley. Ken enlisted in the Air Force on May 15, 1974 and served on active duty with the 15th Military Airlift Squadron, Norton AFB, CA as a C-141 Loadmaster. He separated from active duty in May 1978, spending the next 10 years working in the electronics industry in the Santa Clara Valley. He joined the 129th Rescue Squadron, Air National Guard, at Moffett Field, CA on July 31, 1988 as a C-130 Loadmaster. He attained the rank of Chief Master Sergeant. He remained in the Air National Guard until his death. His military awards include the Meritorious Service Medal, Air Medal, Aerial Achievement Medal, Air Force Commendation Medal, and the Air Force Achievement Medal.

Ken and his wife, Lori, moved to Astoria in March of 2001 when Lori accepted a position with the 116th Air Control Squadron, Air National Guard, at Camp Rilea.

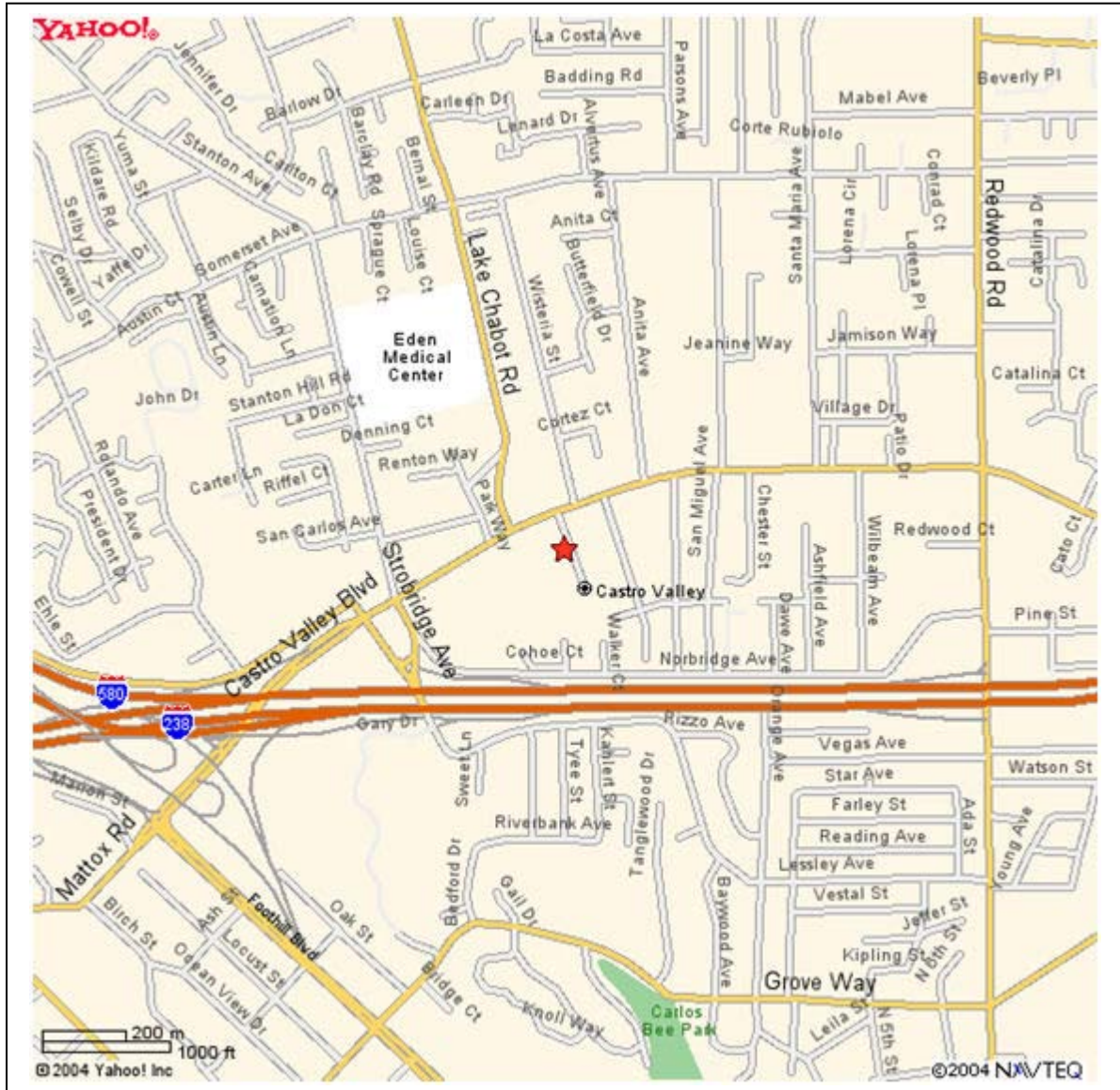

## Decision Time: CRDP and CRSC Open Season

Many military retirees are eligible for both Concurrent Retirement and Disability Pay (CRDP) and Combat Related Special Compensation (CRSC), but, federal law prohibits receiving both. Each year these retirees are encouraged to evaluate and choose which entitlement they prefer to receive during what is called an "Open Season," which runs from Jan. 1 to Jan. 31. These benefits are specific to each retiree's personal situation. For many, the decision comes down to which program offers the better benefit based several factors including payment and tax rates. If you are eligible to participate in the Open Season, you will receive a letter detailing the benefits of each entitlement by mail this month. Along with the letter, you'll receive an Open Season Election Form, which allows you to choose the type of payment you wish to receive. Retirees are encouraged to carefully review their options.

# Department Begins Project for Vietnam War Veterans

WASHINGTON (AFRNS) -- More than three decades after the war's end, the Defense Department has begun a project to pay tribute to the nation's Vietnam War veterans.

The 50th Anniversary of the Vietnam War Commemoration was spawned from the 2008 National Defense Authorization Act.

"It was a very important time period for veterans, because most Vietnam veterans as a whole never received the homecoming that our troops receive now," said Army Lt. Col. Hunter Holliday, public affairs officer for the commemoration.

At the center of the project is a website, "50th Anniversary of the Vietnam War Commemoration," at [www.vietnamwar50th.com](http://www.vietnamwar50th.com), which will serve as a clearinghouse for information on commemoration activities once it is fully functional, a milestone expected this spring.

Information gleaned from the website is expected to be used for myriad purposes, such as to chronicle facts, provide educational materials, and offer resources for a commemorative partners program, Colonel Holliday said.

The partners program will comprise guidance and materials for agencies, veterans groups, local government and nongovernment organizations to conduct their own Vietnam War commemoration activities.

The website is expected to play a major role in the campaign, said Jeff Wilson, who handles marketing for the project, noting it will be highly interactive and will include content on historical events, a timeline, photos, documents, video and audio. A calendar will list major Defense-sponsored events.

The website offers a prelude of activities and ceremonies to:

-- Honor Vietnam War veterans and their families -- including prisoners of war and those listed as missing in action -- for their service and sacrifice on behalf of the United States.

-- Highlight armed forces service during the Vietnam War, in addition to contributions made by government and private organizations.

-- Pay tribute to the contributions made on the home front by U.S. citizens.

-- Highlight the advances in technology, science and medicine in military research made during the war.

-- Recognize contributions and sacrifices made by U.S. allies during the war.

"Hopefully [the commemoration] will be a healing process for the veterans who were never recognized properly when they came home," Colonel Holliday said, noting the volatile political landscape that surrounded the war.

## Reemployment Protection - USERRA Overview

Have you ever wondered what will happen to your civilian job if your Reserve or Guard unit is called into Active Duty? When you return to the civilian world, will you have to search for a new job? What can you do to ensure you'll be able to work again? The following is a summary of the Uniformed Services Employment and Reemployment Rights Act of 1994.

Fortunately, the **Uniformed Services Employment and Reemployment Rights Act of 1994 (USERRA)**, enacted in October 1994 (and significantly updated in 1996 and 1998), provides reemployment protection and other benefits for veterans and employees who perform military service. Under USERRA, if a military member leaves his civilian job for service in the uniformed services, he is entitled to return to the job, with accrued seniority, provided he meet the law's eligibility criteria. USERRA applies to voluntary as well as involuntary service, in peacetime as well as wartime, and the law applies to virtually all civilian employers, including the Federal Government, State and local governments, and private employers, regardless of size.

### USERRA Eligibility

Reemployment rights extend to persons who have been absent from a position of employment because of "service in the uniformed services." "Service in the uniformed services" means the performance of duty on a voluntary or involuntary basis in a uniformed service, including:

- Active duty (Including Reserve and Guard members who have been called up)
- Active duty for training
- Initial active duty for training
- Inactive duty training
- Full-time National Guard duty.
- Absence from work for an examination to determine a person's fitness for any of the above types of duty.
- Funeral honors duty performed by National Guard or reserve members

In order to have reemployment rights following a period of service in the uniformed services, a military member must meet five eligibility criteria (discussed separately below):

1. You must have held a civilian job.
2. You must have informed your employer that you were leaving the job for service in the uniformed services.
3. The period of service must not have exceeded five years. (Certain exceptions apply that may extend the 5 year period, contact the Dept. of Labor for assistance)
4. You must have been released from service under "honorable conditions."
5. You must have reported back to your civilian employer in a timely manner or have submitted a timely application for reemployment.

# ObamaCare Repeal Won't Affect TRICARE

## **3 Reasons the repealing the Patient Protection and Affordable Care Act won't change TRICARE**

A recent article by [Leo Shane of Stars and Stripes](#) explains how and why any actions to repeal the Patient Protection and Affordable Care Act will not make any immediate changes to [TRICARE](#) or the new [TRICARE Young Adult](#) option. In fact there are three main reasons why the actions taken by the House to repeal the act won't change anything right away.

**Reason 1.** When PPAC was passed, Congress quickly followed up by passing the [TRICARE Affirmation Act](#), a law which ensured that TRICARE wouldn't change due to PPAC. Simply put, TRICARE was shielded from the rules for PPAC in the first place, so any repeal won't have an effect anyway.

**Reason 2.** The expansion of TRICARE coverage to include adult children over 21 (known as the TYA option) was not included in the original Patient Protection and Affordable Care Act. In fact TYA is part of the National Defense Authorization Act of 2011, which means that any effort to repeal PPAC will not have an immediate effect. Congress would have to pass a separate bill to eliminate the TYA program.

**Reason 3.** Although the House passed the repeal, it is not likely to get any traction in the Senate and there is no chance that this president will sign any such repeal.

But, this may serve as a gut check, of sorts. How would most TRICARE beneficiaries react to a repeal of the TYA option? Just asking...

**Note from the Author:** *Many readers have voiced concern about the use of the term "ObamaCare." From my perspective the term was widely used in the public domain. I assure you no political commentary was intended. I'll be mindful of the use of such shorthand terms in future postings. Your feedback is appreciated. –Terry*

## TRICARE Announces New Program

DoD announced the new premium-based TRICARE Young Adult program (TYA), which extends medical coverage to eligible military family members to age 26. TYA is expected to be in-place later this spring, but premium costs are not yet finalized. Adults who are no longer eligible for TRICARE, but need health insurance coverage, may wish to explore the Continued Health Care Benefit Program (CHCBP). CHCBP offers temporary transitional health coverage for 18 to 36 months. Coverage must be purchased within 60 days of loss of TRICARE eligibility. OSA also serves as a principal advisor to the Secretary of Veterans Affairs and promotes the use of VA benefits, programs and services to survivors.
